DUTIES: (Summary Only)

Assesses health of individuals (children and/or adults) to detect health defects and determine healthcare needs (e.g., conducts health screenings, obtains health histories, reviews existing examination records, observes behavior and health of individuals, etc.); informs appropriate staff regarding individual's health information; ensures individual's health needs are met; prepares and maintains health records. Provides medical care to individuals and staff who have suffered injury or emergency illness; administers first aid in accordance with established first aid procedures; administers medications as required per doctor's order; makes referrals for individuals in need of medical and/or dental care; uses catheters, feeding tubes, suction machine, bulb syringe, etc. to provide health services. Prepares and submits reports, on behalf of Board, regarding communicable diseases; follows established guidelines and cooperates with local Board of Health in the control and prevention of communicable diseases; provides related training to staff members. Reports individual medical matters, including abuse and neglect, to appropriate authority (e.g., departmental personnel, caseworkers, physicians, clinics, etc.); prepares and maintains various health related reports (e.g., statistical, operational, etc.). Ensures clinic is safe, sanitary and adequately supplied; inventories and orders supplies and equipment; assists facility personnel in establishing sanitary conditions in building. Advises employees working with individuals on modifications to educational programs to meet health needs of individuals; participates with staff in developing and implementing a total individual health program; provides required health training to staff members, including Delegated Nursing Training and monitoring; helps supervise emergency preparedness drills. Attends to physical needs of individuals as necessary (e.g., assists with feeding, toileting, changing soiled clothes, mobility, illness, etc.); lifts, positions, and moves individuals in a safe manner, according to in-service training, using proper lifting techniques. Participates in professional organizations and community groups concerned with improving health service as a positive influence on community health standards; provides information and resource material for staff and students. Works cooperatively with other staff, parents, caseworkers, medical personnel, specialists, etc.

QUALIFICATIONS:

Requires current licensure as registered professional nurse; 6 mos. exp. as registered nurse.

Current certification in CPR. Must successfully pass post-offer/pre-employment physical exam with drug test and agility test; pre-employment criminal background check, Abuser Registry, Nursing Registry, and other registry checks per Statute.
